



**SCHOLARSHIP CRITERIA for Class XI and XII (2021-23)**

- 1.The school has decided to offer 100% scholarship to 15 students and 50% scholarship to 10 students.
- 2.A merit list for scholarship to students shall be made based on the final board result.
- 3.Students securing **95% and above marks in** four mainstream subjects i.e. English, Mathematics, Science and Social Science in the AISSE 2021 may apply on or before **15.08.2021**. The details of payment to be made under 100% / 50% Scholarship is as given below:

- 4.Students qualified for the Scholarship will get their deposited fee refunded as applicable.
- 5.The validity of the scholarship is for two successive academic sessions from the date of admission, provided the student is promoted to Class XII with at least **75 percent** marks in individual five main subjects of the scheduled examinations as printed in the almanac. Also note that even if the retest is conducted for general category, it will not be valid to continue the scholarship. Thereafter, the **scholarship will be withdrawn** automatically in class XII without any intimation and thereby the student/parent/ guardian will have to pay the fee for class XII as per the fee structure of the school for the academic session 2022-23.
- 6.**100% scholarship** students applying for **boarding facility** will get **50% exemption on hostel fees**.
- 7.**50% scholarship** students applying for **boarding facility** will get **25% exemption on hostel fees**.
- 8.Grant of scholarship and continuation of it in class XII is the sole jurisdiction of the school management and shall be final and binding in all respects.
- 9.Students who have been granted scholarship will have to deposit **scholarship caution money\*** of **Rs. 20,000/-** which will be refunded only if the student availing the scholarship completes Classes XI & XII from DPS Guwahati and also abides by the scholarship criteria in Class – XII.
